## The World Diamond Council 2016 Annual General Meeting to be held in New York in September

The meeting will be hosted by the United States Jewelry Council and Signet Jewelers will serve as the event's Premier Sponsor

**NEW YORK, NY, August 4, 2016** — The World Diamond Council (WDC) has announced that its  $12^{th}$  Annual General Meeting (AGM) will take place at the Waldorf Astoria Hotel in New York City from Sept. 7 – 9.
